Collegiate Education – Implementation of scheme “Special Care for Slow Learners in order to prevent College drop outs” – Funding support for 12 new Government Arts and Science Colleges (without 12(B) & 2(f) Status) sanctioned for the year 2019-20 – Order – Issued.

ORDER:

In the G.O. first read above the Government have accorded an administrative sanction of Rs.30.00 lakhs per annum for 17 Government Arts and Science Colleges and 27 University Constituent Arts and Science Colleges started till the year 2010-11 which did not have 2(f) and 12(B) status to implement the scheme of “Special care for Slow Learners in order to prevent college drop outs” for the 3rd year students of BC, General category etc., (non-creamy layer).

2. In the G.O. second read above an amendment was issued to implement the above said scheme in 6 Government Arts and Science Colleges and 18 University Constituent Arts and Science Colleges totalling to 24.

3. Now, the Member Secretary, Tamil Nadu State Council for Higher Education has stated that as on 2018-19, 29 Colleges, (both Government and Constituent) are yet to obtain 12(B) and 2(f) status. Hence, he has requested permission to extend funding support for the 12 new colleges from 29 Colleges under the scheme “Special Care for Slow Learners in Order to prevent college drop out (for colleges without 12(B) and 2(f))” for the year 2019-20.

4. The Government have examined the proposal and decided to accept the proposal of Member Secretary, Tamil Nadu State Council for Higher Education and accordingly grant permission to include 12 new Colleges [without 12(B) and 2(f) status] to utilize the grant sanctioned for the scheme “Special care for Slow

Learners in order to prevent college drop outs" stipulating the conditions mentioned in the G.O. first read above.

5. As the Member Secretary, Tamil Nadu State Council for Higher Education has stated that out of 24 beneficiary colleges sanctioned in G.O. second read above 12 colleges obtained 12 (B) and 2(f) status leaving 12 colleges without 12(B) and 2(f) status. Hence, it is directed that along with these 12 colleges without 12(B) and 2(f) status, (as in annexure-II) the 12 colleges now permitted in this order (as in annexure-I) totaling to 24 colleges shall get the financial support and will be the beneficiaries under this scheme.
