In the letter third read above, in order to extent the benefit for all trainees, the Director of Employment and Training has sent proposal seeking equivalence to all State Council for Vocational Training (SCVT) & National Council for Vocational Training (NCVT) certificate holder's institutions.
- 3. In the letter sixth read above, among others, the Member Secretary, Tamil Nadu State Council for Higher Education has stated that,
 - a) The Hon'ble High Court of Madras in its order first read above has ordered to assess the equivalence on certificate course, Cutting and Tailoring offered by Central Training Institute - National Council for Vocational Training as to whether equivalent to Needle Work and Dress Making (Higher Grade) – Industrial School Certificate from Department of Employment and Training, Government of Tamil Nadu.
 - b) With reference to the request of the Director of Employment and Training, the council has to obtain the syllabi, analysis with subject experts and place the recommendations obtained before the Equivalence Committee to pass resolutions and in due course will be forwarded to issue necessary orders.
- 4. The Tamil Nadu State Council for Higher Education has therefore requested to initiate action to issue necessary Government order in accordance with law on resolutions passed in the Fourteenth Equivalence Committee based on W.P filed in the High Court of Madras at the earliest to avoid contempt of Court.
- 5. The Government after careful examination accept the request of Tamil Nadu State Council for Higher Education and accordingly, granting the equivalence for the courses, in accordance with the resolutions passed in the Fourteenth Equivalence Committee meeting held on 07.02.2022, as in para 1 above.
