ORDER:

The Government have examined the proposal whether B.Sc.(Applied Zoology) of Madurai Kamaraj University can be considered as equivalent to B.Sc.(Zoology) of Madras University for purpose of recruitment to the post of Laboratory Assistant in the Tamil Nadu Fisheries Subordinate Service and that M.Sc. (Integrated Biology) (Micro Biology) of Madurai Kamaraj University as equivalent to M.Sc.(Zoology) of the Madras University for purpose of appointment to posts in State and Subordinate Services. The Tamil Nadu Public Service Commission and the Madras University who were consulted in the matter, have agreed for the recognition of above said qualifications for purpose of appointment in Government Service.

2. The Government accordingly direct that (i) the B.Sc.(Applied Zoology) of the Madurai Kamaraj University be recognised as equivalent to B.Sc.(Zoology) of the Madras University for the purpose of recruitment to the post of Laboratory Assistant in Tamil Nadu Fisheries Subordinate Service; and (ii) the M.Sc.(Integrated Biology) (Micro Biology) of Madurai Kamaraj University be recognised as equivalent to the M.Sc.(Zoology) of the Madras University for purpose of appointment to posts in the State and Subordinate Services.
