ORDER:-

In the letter second read above, the Member Secretary (i/c), Tamil Nadu State Council for Higher Education, has forwarded the resolutions passed in the 25th Equivalence Committee meeting (through circulation) on 15.03.2024 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the Equivalence of Degree viz. M.Sc. Information Technology awarded by The Gandhigram Rural Institute (Deemed University) to M.Sc. Computer Science for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolution passed in the 25th Equivalence Committee meeting (through circulation) on 15.03.2024, under the Chairmanship of the Principal Secretary to Government, Higher Education Department from the date of issuance of such degrees:-

The Government also direct that no person shall be eligible for appointment to any service, class, category or grade or any post borne on the cadre thereof, unless he possesses such special qualifications and has passed such special tests as may be prescribed in that behalf in the special rules; or possesses such other qualifications as have been declared to be higher than or equivalent to the said special qualifications or special tests, by the Government in consultation with the Committee constituted in the Government Order first read above and by the Government or by the appointing authority with the approval of the Government in other cases.


